#### Regional Seminar on Anti-Cyber Crime Techniques in Korea

#### 13 - 15 May 2014, Cheonan, Korea

#### Cyber-crime

Nowadays, Customs officers, in particular, Customs investigators have to face not only traditional investigation but also cyber-crime investigation. There is an increasing trend for criminals to commit Customs offences by making use of digital equipment. Dangerous drugs traffickers may communicate with each other via mobile equipments. Counterfeit medicines are sold on the internet. Illegal proceeds are transferred through internet banking. Thousands of transactions of illicit trade are completed through the internet and digital communication tools.

Then three main issues will arise. First, how do we conduct cyber-crime investigation and track and trace suspects in the cyber-world? Second, how should we manage digital crime scenes? Third, how would digital evidence be processed and analyzed to make it admissible in the trial?

To coordinate the capacity building development in relation to cyber-crime in Asia Pacific region, World Customs Organization Asia Pacific Regional Office for Capacity Building (ROCB A/P) sent a representative to attend the Regional Seminar on Anti-Cyber Crime Techniques on 13-15 May 2014 in Cheonan, Korea. The Seminar was organized by Regional Intelligence Liaison Office for Asia and the Pacific (RILO A/P) in collaboration with Hong Kong Customs and Korea Customs Service. The Seminar aimed at providing the participants with concepts on cyber-crime and enriching their skills in handling the increasing volume of forensic-related investigations. The Seminar covered essential topics of network investigation, crime scene management and computer forensic analysis.



### Regional Seminar on Anti-Cyber Crime Techniques in Korea

47 participants from24 Customs administrations attended the Seminar and the programs were completed successfully. Thanks to Hong Kong Customs, Korea Customs Service and speakers from other Customs Administrations, participants deepened basic and practical anti-cyber-crime techniques. In addition, the Seminar did provide practical guidance for Internet/Network Investigation, Crime Scene Management and Digital Forensics.

ROCB A/P has taken note of the success of the Seminar and is trying to provide a platform for the development of capacity building in relation to cyber-crime. On top of the Good Practice Report on Computer Forensics (uploaded onto WCO CLiKChttp://clikc.wcoomd.org/)written by Hong Kong Customs and Malaysia Customs, we are trying to coordinate good practice reports on Cyber-crime Investigation and

In tandem with the advancement in information technology, technology-related crimes have also increased sharply in recent years. To gear up the Customs Administrations against the challenge of technology-related crimes, it may be time for relevant authorities to review whether resources should be re-allocated to set up cyber-crime investigation office and to invest on the equipment for cyber-crime investigation.

#### TRS Exit Conference 2014

29 April 2014, Putrajaya, Malaysia

The Malaysia Time Release Study (TRS) Exit Conference was held at Pullman Putrajaya Lakeside Hotel, Malaysia on 29th April 2014. Among the Royal Malaysia Customs Department (RMCD)'s participants was Penang State Director of Customs, Customs Academy Director, and some HQ Deputy Directors of Customs with State's of Customs Division and State TRS Team leaders has attended the conference.

The conference is supported by Asia Development Bank (ADB), Japan Fund for Poverty Reduction and Japan International Cooperation Agency (JICA) and participated by about 130 delegates from the trade community, other government agencies (OGAs), industries, universities and public research organizations.

In his opening address, Deputy Director General of Customs (Customs and GST) Dato' Hj. Zainul Abidin bin Taib, on behalf of the Director General highly commended that the RMCD has taken much effort and initiatives to fulfill the calls from the World Customs Organization (WCO)'s requirements, as well as the World Trade Organization (WTO) pertaining to the implementation of trade facilitation tools and initiatives.

He added that, Malaysia TRS has been undertaken in 2003, 2007, 2009, 2011 and 2012. However, the study has been done through various questionnaire designs respectively. The TRS

2012 is using a comprehensive and consolidated questionnaire based on the WCO TRS Guideline Version 2.0. under the ASIA Cargo Highway Initiative (ACHI).

The RMCD hope that this conference provides a platform to share knowledge and findings of the TRS Malaysia with stakeholders and trade communities pertaining to the cargo clearance processes. From these findings, many suggestions were recorded that will acknowledge parties concerned, the bottlenecks of the cargo clearance process, as well as to take some suitable efforts for improving the procedures related with.

During the conference, five presenters have presented their paper of various issues and challenges on TRS. The CCF/Japan Operation Manager and Program Manager for South Asia, Mr. Takayuki Miyoshi has covered the WCO and Asia Pacific region for trade facilitation. It was followed by Mr. Sunichi Hinata, Regional Cooperation Specialists from ADB that discussed the ADB's support to trade facilitation and and TRS in South East Asia. Moreover, the Japan

Customs has shared their TRS experience via Mr. Noburu Kurita, JICA expert to RMCD.

Two senior customs officials from RMCD have presented and disseminated the TRS Report 2012 and TRS 2014 Roadmap. Dr. Mohd Afandi Md Amin has presented TRS 2011 and 2012 reports and its findings, while Dr. Hosni Hussen Md Saat presented the proposed methodology and term of reference for the TRS 2014.

The conference has received many feedbacks from participants pertaining to the TRS such as the ways to improve the study, Japan TRS experience comparison to Malaysia, the actual cross border efficiency measures, and many related issues on TRS implementation and Customs procedures for importation of goods.

The participants, particularly from trade communities, customs brokers, traders, logistic operators, researchers and freight forwarders have expressed their gratitude to RMCD and ADB together with their


strategic partners for holding the conference successfully by unlocking the Pandora box of Customs' processes and procedures to the public.



#### A Journey of Cambodia to RKC

#### 28 June 2014, Brussels, Belgium

In the Strategy and Work Programs on Reform and Modernization of Cambodia Customs (2009-2013), under Strategic Objective 3, Cambodia Customs has set an important plan to modernize customs system, procedures and technique in order to maximize trade facilitation by becoming a contracting party to the Revised Kyoto Convention (RKC).



After more than two years of hard works and well-planned preparations, Cambodia finally became 94th member of the RKC when Dr. Pen Siman, Delegate of the Royal Government in Charge of the General Department of Customs and Excise deposited the Instrument of Accession with the Secretary General of the WCO during the 123rd/124th Sessions of the Customs Co-operation Council on 28th June 2014.

Cambodia acceded to the convention through article 3, which means the acceptance of the body and the general annex. Furthermore, Cambodia decided to accept, without reservations, Chapter 2 of Specific Annex A, Chapter 1 of Specific Annex B and Chapter 1 of Specific Annex C under Appendix III. In accordance with the provision of the RKC, the said Convention will come into force for Cambodia 3 months after the deposit of the Instrument of Accession.

Becoming contacting party of RKC requires a number of important tasks to fulfill such as the assessment of national legislation, identification of the legislation and regulations needing to be amended and developed, and establishment of management and expert team for the preparation. The main process are summarized in the below table.

#### A Journey of Cambodia to RKC



As shown in the table, administrative endorsement and legal approval process is recognized the most challenging step as it needs to go through several rigorous discussions and reviews by relevant Committees of the Council of Ministers, National Assembly and the Senate respectively before passing to their plenary sessions for formal approval. According to the timetable above, Cambodia spent more than 1 year to go through the administrative endorsement and legal approvals.

Cambodia's accession to and the implementation of RKC will benefit all players from business, customs and country as whole in term of improving trade competiveness, increase revenue collection, reducing the transaction cost, improving business climate, attracting foreign direct investment, promoting trade and sustainable economic development.

The accession to RKC is an important historical event for the country, especially for the business community because this convention is the only compact documents of customs procedures, international standards and best practices of over 500 standards. The provisions of this convention will be a foundation for reform

and modernization of Cambodia customs. The acces sion to the Convention also sends a positive message to the world business community about the government commitment for improving trade facilitation and customs reform and modernization. Moreover, it reflects that government service for the international trade, business transaction, investment climate in Cambodia is being carried out on the rule-based environment and using international standards.

In accordance with the World Bank's Report, Cambodia LPI ranking has risen spectacularly by 46 places, to 83 in 2014 out of 160 countries, from 129th in 2010. This improvement can be linked to the time to clear customs which felt from 5.9 days in 2010 to only 1.4 day in 2014. The GDP growth was maintained at average of 7% in the same period. The volume of international trade has increased from USD10 billions in 2010 to about USD20 billions in 2013, which resulted in more revenue collection by customs. The World Bank also reported that the poverty rate in Cambodia felt from 45% in 2007 to about 20% in 2011.

It is expected that further improvement of investment climate and trade facilitation which contribute to sustainable economic development will be repeated after Cambodia accession to the RKC.

## ROCB A/P contributed to the 5th Capacity Building Committee in Belgium

#### 31 March – 2 April 2014, Brussels, Belgium

The 5th session of the WCO Capacity Building Committee (CBC) was held in Brussels from 31 March to 2 April 2014. Around 240 registered high-level participants from WCO Member administrations and stakeholder organizations attended this grand meeting. Mr. Yoshihiro Kosaka, Head of the ROCB A/P, together with other ROCB A/P staff attended this important meeting.

WCO Secretary General opened the session and summarized the broad range of work delivered since last year's meeting. He noted that it was a critical moment for all Customs administrations to consider their strategies following the recent adoption of the WTO Agreement on Trade Facilitation and reassured members that the WCO was well positioned to assist

Members in the implementation of the provisions of the Agreement, as well as providing continuous support for Customs reform and modernization programmes. Director for Capacity Building briefed the Committee on the WCO Capacity Building Progress Report since the last session of the CBC in February 2013.

In the following two day meeting, the Committee welcomed and/or endorsed several documents/initiatives, including the EU Customs Competency Framework; the WCO Framework of Principles and Practices on Customs Professionalism; the WCO People Development Interactive Map on the CLiKC! Platform; the new WCO Gender Equality Organizational Assessment Tool; the update of the Chapter on Donor Engagement of the WCO Capacity Building Development Compendium; the envisaged development of a WCO People Development/Training Diagnostic Tool, etc.

On the panel discussion on Donor Engagement, Mr. Kosaka delivered a presentation on Donor Engagement efforts in A/P region. He pointed out that collaboration with donors or development partners has been one of the top priorities for the A/P region. The ROCB A/P facilitated the organization of regional donor conference in 2012 and has been assisting customs administrations in the A/P region to organize a national donor conference, which are very important to the countries in need. The ROCB A/P further organized a resource mobilization workshop in February 2014 to further enhance national capacity of customs administrations to consult with prospective development partners. Mr. Kosaka's presentation was well received by the global customs community.

In the margins of the meeting, all ROCB A/P staff were given an opportunity to meet the Secretary General. The Secretary General recognized and commended the ROCB A/P's efforts in the delivery of a wide range of high-quality capacity building activities to the members. He also encouraged all ROCB staff to make more contribution to the regional development in various domains.



#### The WCO/ICAO Joint Conference on Air Cargo Security in Bahrain

#### 15-18 April 2014, Manama, Bahrain

The World Customs Organization (WCO) and the International Civil Aviation Organization (ICAO) jointly organized a conference on air cargo security and facilitation in Manama, Bahrain on 15-18 April 2014. This Conference was hosted by the Kingdom of Bahrain and was attended by over 300 participants from 42 countries, 50 international and regional organizations and industry stakeholders. At the invitation of the WCO, Mr. Yoshihiro Kosaka, Head of the ROCB A/P, participated in this Conference.

The Joint Conference acknowledged that a secured and efficient air cargo supply chain is essential for international trade and world economic development. In discussing the various challenges faced by the cargo industry today, the ICAO and the WCO reiterated the importance of cooperative approach for the establishment of a robust, sustainable and secure supply chain at global, regional and national levels.

During the conference, Mr. Kosaka had a series of bilateral discussions with the WCO and ICAO's executives and officers-in-charge on the arrangement of relevant capacity building programs. The idea of a joint pilot workshop in Bangkok was very well received by the Secretary Generals of both the WCO and the ICAO and other executives of two organizations. Following the discussions, the ROCB A/P has been tasked to work closely with the WCO and the ICAO to design and organize this project in the near future. Preparatory work is now well underway.



## ROCB A/P contribution to the Regional Steering Group (RSG) meeting and WCO Asia Pacific Regional Heads of Customs Administrations Conference in Australia

#### 29 April - 2 May 2014, Port Douglas, Australia

The WCO Asia Pacific Regional Heads of Customs Administrations (RHCA) Conference was held in Port Douglas, Australia from 29 April to 2 May 2014. Prior to the RHCA, the Regional Steering Group (RSG) Meeting was held on 28th April 2014. The RHCA Conference was hosted by the Australian Customs and Border Protection Service (ACBPS) and was attended by delegates from 24 countries and the WCO regional Structures in the A/P region. Mr. Yoshihiro Kosaka, Head of ROCB A/P attended the meeting.

The Conference endorsed several issues of key importance to the region, including the Regional Strategic Plan 2014-2016, the Terms of Reference for the Regional Office for Capacity Building (ROCB), the Regional Customs Laboratory initiative, and the WCO regional representatives for the coming financial year. In this meeting, Mr. Kazunari Igarashi was elected as the new Head of the ROCB A/P for a five-year term. Regional Heads of Customs administrations discussed a wide range of topics, including Capacity Building (CB) activities; enforcement activities;

engagement with trade; integrity; governance; the election process for WCO officials; and emerging issues, particularly the challenge of e-commerce. The Conference also heard activity reports from the RILO and the ROCB A/P. The Region further agreed on the necessity of an annual decision-making mechanism, the details of which will be finalized following further reflection on the matter.

During the meeting, Mr. Kosaka made a presentation which outlined the ROCB A/P. It provided a report on the role and recent key areas of activity and operation of ROCB A/P, including the ROCB A/P today, the regional CB strategy, and some food-for- thought for further improvement of regional CB. He also expressed his appreciation to regional members who contributed to the regional CB activities, and their continued support during his 5-year tenure as the Head of the ROCB A/P. The meeting thanked him and the ROCB A/P for their valuable contribution for the region with a round of applause.

#### 2014 WCO IT Conference and WCO Regional Workshop on Leadership in Single Window and WCO Data Model in Australia

5 - 9 May 2014, Brisbane, Australia




The WCO Regional Workshop on Leadership in Single Window and WCO Data Model was held from 5 to 9 May 2014 in Brisbane, Australia under the sponsorship of the Customs Cooperation Fund, Japan (CCF/Japan) and in collaboration with the Australian Customs and Border Protection Service (ACBPS). It was attended by 36 participants from 24 Customs administrations in the Asia Pacific region and 3 additional participants from the United States and Namibia. Mr. Satya Prasad Sahu, Senior Technical Officer from WCO, together with the experts from the World Bank, Korea Customs Service, Royal Oman Police, and Netherlands Customs, facilitated the Workshop. Mr. Takayuki Miyoshi, CCF/Japan Operation Manager and Project Manager of ROCB A/P for South Asia and Ms. Pariyabhat Ariyapongkoson representing the ROCB A/P also attended the Workshop as facilitators.

The Workshop was aimed at senior executives in Customs administrations and was a combined with the WCO IT Conference & Exhibition 2014. Two days were focused on theoretical presentations and practical

case stories, as well as exercises where participants were involved in identifying and dealing with the strategic issues in building a Single Window Environment. Participants were also exposed to key management aspects of Single Window functional assessment, Business Process Development, Data Harmonization using the WCO Data Model and Dematerialization.

Prior to the two-day lecture sessions, participants were invited to attend the three-day WCO IT Conference & Exhibition and to interact with the exhibitors in order to help them contribute to the final session of the Workshop with regard to "Developing a list of features for a National Single Window". The participants actively exchanged their views on presentations delivered and case stories provided from the experts both during the Workshop and in the breakout sessions. As a result of very fruitful discussions among participants and experts, the participants greatly improved their understanding of the goals and strategic priorities to be clarified in developing a Single Window solution from a Customs and Border Management perspective. The participants expressed their appreciation to the WCO and the ROCB A/P for organizing the Workshop.



#### WCO Asia Pacific Regional Workshop on Risk-Based Passenger Selectivity in Korea

#### 9 - 13 June 2014, Cheonan, Korea

The ROCB A/P in cooperation with the WCO and Korea Customs Service (KCS) organized the WCO Regional Workshop on Risk-based Passenger Selectivity from 9 to 13 June 2014 at the WCO Regional Training Centre in Cheonan, Korea under the sponsorship of the Customs Cooperation Fund, Japan (CCF Japan). A total of 33 representatives from 28 Customs administrations in the Asia Pacific Region participated in this workshop.

This 5-day workshop covered the main elements of operational risk management and then focused on risk-based passenger selectivity by examining several elements of risk assessment, profiling and targeting, including information and intelligence.

Some elements of risk management at the organizational level were also covered throughout the workshop with several syndicate group tasks, practical exercises, case studies and country presentations.

The spotlight was put on passenger selectivity. Each session was followed by lively discussions, questions and answers.

During the syndicate group tasks and country presentations, participants entered into in-depth discussions on how to identify high-risk passengers by utilizing the methodology explained in the WCO Customs Risk Management Compendium. Case studies and practical exercises also contributed to deepening an understanding of the topics.

Participants had a study visit to the K-9 Center of KCS and Incheon International Airport which was chosen as the world's best airport in service quality for the ninth consecutive year on the last day of the workshop. Participants had a chance to observe the operation of Advance Passenger Information (API) and Non-Intrusive Inspection (NII) system at Incheon Airport Customs.



#### WCO Sub-regional Train-the-Trainer Workshop on HS for Pacific Islands in Fiji

9 - 13 June 2014, Suva, Fiii



The WCO Sub-Regional Train-the-Trainer Workshop on the Harmonized System (HS) was held at the Regional Training Center in Suva, Fiji, from 9 to 13 June 2014 under the sponsorship of the Japanese Customs Cooperation Fund (CCF/Japan). 15 participants from six Customs Administrations (Fiji, Papua New Guinea, Samoa, Timor-Leste, Tonga and Vanuatu) participated in this workshop. Ms. Ben Chamkrom, Program Coordinator of the ROCB A/P joined this workshop as a facilitator.

During the Workshop a wide range of HS-related matters were addressed and the 15 participants were thoroughly informed about the fundamental classification infrastructure and principles of the General Rules and practicalities of HS classification to ensure correct and uniform application. Following a range of

presentations on training techniques, participants had an opportunity to exercise their skills through dealing with classification-related questions. As a result, participants are now better prepared to conduct HS training in their home respective administrations.

Throughout the seminar, the participants were encouraged to continue in-house-training to improve their classification infrastructure, introduce advance ruling programs and to improve internal and external communication. Members who are not yet HS Contracting Parties were also invited to accede to this fundamental international instrument.

#### WCO National Intellectual Property Rights (IPR) Seminar for Thailand

#### 24-27 June 2014, Bangkok, Thailand

As one of the celebration events of the 10th Anniversary of ROCB A/P, the Asia Pacific Regional Office for Capacity Building (ROCB A/P) in cooperation with the WCO and Thai Customs organized a WCO National Seminar on Intellectual Property Rights at the Thai Customs Academy, in Bangkok, Thailand from 24 to 27 June 2014 under the sponsorship of Japan Customs Cooperation Fund (CCF/Japan).

Two IPR experts from the WCO and India Customs facilitated the Seminar, which was attended by 39 participants from 10 Thai Customs Bureaus. Also, representing the ROCB A/P, Mr. James Kai Wah Wong, Project Manager for South East Asia and Ms. Pariyabhat Ariyapongkoson, Program Coordinator attended the Seminar as facilitators. The Seminar was aimed at enhancing participants' awareness of the threat posed by counterfeit goods and knowledge and techniques in fighting against such threat. The application of TRIPS' Agreement and the WCO Interface Public-Members (IPM) were introduced.

During the seminar, 10 representatives of right holderprovided presentations on identification of genuine and counterfeit goods. In the presentations, information on the locations of where genuine goods are produced, the normal transportation routes and descriptions of the goods was shared. Practical exercises in relation to risk assessment and selection of suspicious cargoes were given to the participants respectively. Participants gave positive feedback and were able to apply what they had learned immediately. On the last day of the Seminar, the participants visited Thailand's Department of Intellectual Property (DIP) which is responsible for the registration of various intellectual property rights such as trademarks, and patents. The department is also involved in amendments of IPR laws, copyright recordation and coordination of law enforcement in fighting against counterfeit goods and promotion of awareness of IPR protection in Thailand. The WCO experts and the ROCB A/P facilitators exchanged practical ideas with the representative of DIP concerning trademark recordation process and the active role and function of DIP in IPR protection.



#### 23rd Meeting of the ASEAN Directors General in Vietnam

#### 2 - 3 June 2014, Dalat, Vietnam

On the occasion of the 23rd ASEAN Directors General of Customs meeting in Da Lat, Vietnam, a WCO/ASE-AN Consultation session was held on 3 June and the Head of the ROCB A/P joined the WCO Secretary General for this important meeting.

In the run up to the implementation of the ASEAN Economic Community (AEC) in 2015, the Directors General of ten ASEAN countries reviewed the progress made to date on enhanced economic integration within ASEAN. During this meeting, both the ASEAN and the WCO updated each other on new initiatives and progress made since last year's meeting. The WCO was particularly pleased to observe the great steps forward in national processes to ratify the Revised Kyoto Convention made by ASEAN members yet to accede to this instrument. Following the exchange of views on international customs development and the WCO-ASEAN collaboration, ROCB A/P made a presentation on the past and planned activities on ASEAN-related Capacity Building. At the end of the meeting, the Director Generals of ASEAN expressed their appreciation to the Head of the ROCB A/P and its staff for their dedicated work to support customs administrations in ASEAN.

Taking this opportunity, the WCO delegate met with members of the US-ASEAN Business Council to exchange views on the progress and expectations of the ASEAN Customs administrations. He stressed the importance of the role played by business in improving compliance and communication with Customs and 22 also in advocating Customs' role to political leaders.

The Business Council members thanked WCO for this

dialogue prior to their consultation session with the ASEAN Directors General.

All the participants expressed their gratitude to Vietnam Customs and its Director General, Mr. Tuc, for its warm hospitality and excellent organization of the event.



#### ROCB A/P contribution to the ADB Exit Conference on Customs Time Release Study (TRS) for Malaysia

29 April 2014, Putrajaya, Malaysia

The Royal Malaysian Customs Department in cooperation with the Asian Development Bank (ADB) organized the Exit Conference on Customs Time Release Study (TRS), in Putrajaya, Malaysia on 29 April 2014. The conference was attended by about 130 participants from the Customs Department, the private sectors, and other government authorities. At the organizers invitation, Mr. Takayuki Miyoshi, CCF/Japan Operational Manager and Program Manager for South Asia joined the conference as a resource person.

The main objective of the Conference was the release by the Royal Malaysian Customs Department of the findings of their 2012 TRS, and an opportunity to hear feedback from all stakeholders, including the private sector and other government authorities. The plan for the next TRS was also released during the conference. In his presentation, Mr. Takayuki Miyoshi introduced the outline of the WCO and the ROCB A/P, the WCO initiatives for the implementation of WTO ATF, and the WCO TRS instrument and TRS agenda in the Asia Pacific. His presentation was well received by all the participants.



#### ROCB A/P contribution to the IFCBA Global Conference in Korea

#### 14 - 16 May 2014, Seoul, Korea

In response to the request from the WCO Headquarters, Mr. Yoshihiro Kosaka, Head of the ROCB A/P, participated in the International Federation of Customs Brokers Association (IFCBA) global conference that was held in Seoul, Korea on 14-16 May 2014. Around 300 participants attended the conference.

Mr. Kosaka delivered an opening speech on behalf of the Secretary General of the WCO. He congratulated the IFCBA on their 25th anniversary and outlined the importance of business partnership in the modern customs environment. He also highlighted the role of customs brokers in the implementation of WTO Agreement on Trade Facilitation.

During the conference, Mr. Kosaka was invited to outline the customs capacity building in the Asia Pacific region. A number of important points were covered, including WCO and A/P capacity building structure,





regional capacity building strategy, WTO Agreement on Trade Facilitation and some examples of customs business partnership on capacity building. The presentation attracted great interest of the participants.

Mr. Kosaka's contribution to the conference was very well received by the participants. The IFCBA expressed their special appreciation to the participation of the WCO and its intension to continue inviting WCO and ROCB A/P for the next conference.



## ROCB A/P Contribution Workshop on Effective Practices in Transnational Cooperation in the Border Enforcement of Intellectual Property Rights (IPR) in Thailand

19 - 21 May 2014, Bangkok, Thailand

Upon the invitation of the United States Patent and Trademark Office (USPTO), Mr. James Wong of WCO ROCP A/P attended, as a speaker and panelist, the Workshop on Effective Practices in Transnational Cooperation in the Border Enforcement of Intellectual Property Rights held in Bangkok, Thailand from 19 to 21 May 2014.

The workshop was jointly organized by the USPTO and the ASEAN Secretariat. Thirty-eight participants from various parties including 9 Customs administrations of ASEAN countries, China and the United States of America, attended the workshop.

The workshop was very successful and participants shared and exchanged practical knowledge and experience in fighting transnational illicit trade in particular counterfeit goods. WCO tools, such as the Risk Management Compendium, Interface Public Members (IPM) and trade mark recordation, Customs Enforcement Network (CEN), and anti-counterfeiting operations, were introduced during the workshop. The WCO contribution to anti-counterfeiting activities was appreciated.





### ROCB A/P Contribution to the SASEC Second Meeting of the Customs Subgroup in Nepal

#### 21 - 24 May 2014, Kathmandu, Nepal

The Asian Development Bank (ADB) in cooperation with Nepal Customs organized the South Asia Sub-regional Cooperation (SASEC) Second Meeting of the Customs Subgroup in Kathmandu, Nepal on 22-23 May 2014. ### WCO/ADB National Workshop on Transportation and Trade Facilitation Monitoring Mechanism (TTFMM) for Nepal

15 - 17 April 2014, Kathmandu, Nepal

The WCO, the Asian Development Bank (ADB) and the United Nations Economic and Social Commission for Asia and the Pacific (UNESCAP) jointly organized a national workshop on Trade and Transport Facilitation Monitoring Mechanism (TTFMM) for Nepal from 15 to 17 April 2014. At the organizers invitation, Mr. Jing Cheng, Program Manager for Pacific Islands of the ROCB A/P joined this workshop as a resource person on behalf of the WCO.

The TTFMM program aims to strengthen the capability of the SASEC (South Asia Sub-regional Economic Cooperation) members in examining their self trade barriers through the combined use of performance measurement instruments and tools, such as Business Process Analysis, TRS and Time Cost and Distance. The main objective of the national workshop was to assist the individual countries to develop a suitable strategy for better implementation of these tools, taking their actual geographical and trade situation into consideration.

During the workshop, Mr. Cheng introduced the WCO Time Release Study Guidelines, a useful tool to improve the overall border performance. The convening parties of the workshop thanked the WCO for the valuable contribution to this workshop.



ROCB A/P Contribution to the Greater Mekong Sub-region (GMS) Transport and Trade Facilitation (TTF) Development Partners' Meeting in Philippines

#### 22 - 23 April 2014, Manila, Philippines

The Greater Mekong Sub-region (GMS) Transport and Trade Facilitation (TTF) Development Partners' Meeting was held in Manila, Philippines from 22 to 23 April 2014. The meeting gathered a total of 37 representatives from various international organizations, such as JICA, UNESCAP, WCO, etc. At the invitation of the Asia Development Bank (ADB), Mr. James K W Wong, Program Manager for South East Asia of the ROCB A/P, attended this meeting.

#### WCO/ADB National Workshop on the Revised Kyoto Convention (RKC) for Myanmar

The ROCB A/P, in cooperation with the WCO and the Asian Development Bank (ADB) organized the WCO national workshop on Revised Kyoto Convention (RKC) in Yangon Myanmar from 28 to 30 May 2014. As one of the follow-up activities, this national workshop was held to provide the targeted technical support to Myanmar Customs based on the gaps identified in the sub-regional workshop.

The tangible outcomes of this workshop include improved understanding of the RKC, particularly on its benefits. By conducting a gap analysis, they now have a clear roadmap to accede to the RKC in the near future. The experts agreed to render ongoing support to Myanmar Customs as appropriate.

#### ADB/WCO National Workshop on Revised Kyoto Convention (RKC) Implementation for Bhutan

#### 9 - 12 June 2014, Thimpu, Bhutan



Responding to the needs expressed by the Department of Revenue and Customs (DRC) of Bhutan, the WCO in cooperation with the Asian Development Bank (ADB) delivered a 4-day national Workshop on the Revised Kyoto Convention (RKC) Implementation in Thimpu, Bhutan on 9-12 June 2014.
