1. Message from the Director General of the WCO A/P RCL Korea

I'm Jin-Cheol Yang, the Director General of Central Customs Laboratory.

It is my pleasure that I write to you as the Head of Central Customs Laboratory (CCL) Korea.

Welcome to the Regional Customs Laboratory (RCL) Korea brief.

It is my great honour to notify you that on July 11th, 2022, I was appointed Director General of CCL Korea which also acts as the WCO RCL.

I would like to show my appreciation to all the members in the region for your continuous and full cooperation and partnership. I have been aware of the importance of the roles of the customs laboratory as the circumstances in which we live change more rapidly and unpredictably than ever before. I hope we will work closely with you and contribute to the development of the customs laboratory.

From the second half of last year to the first half of this year, the RCL Korea has carried out. The following activities:

- The RCL Korea attended the 2021 Latin America and the Caribbean (LAC) Online Workshop on Capacity Building for Digital Customs and delivered a presentation on analytical technology.
- The RCL Korea ran Customs Laboratory Professionals Programs in order to strengthen the partnership with and increase its contribution to the development of its Uzbek counterpart.
- The RCL Korea has attended sessions of the Harmonized System Committee (HSC),
 Harmonized Review Sub-Committee (RSC), and Scientific Sub-Committee (SSC) in
 order to enhance our cooperation with other WCO members by sharing
 information on classification of goods and products and providing support and
 cooperation.
- Owing to the Covid-19 situation, The RCL Korea participated in the first RCL Heads meeting online where the participants shared information and promoted our activities.
- The RCL Korea participated in the Regional Seminar on Drugs and Drug Precursors held by RILO AP in June 2022.

I believe that by extending our cooperation and sharing knowledge of customs analysis, we will continue supporting one another and strengthening the relationship among all the members. I look forward to your support and cooperation.

2. Customs Laboratory Professionals Program

('Nov. 15, 2021 - Nov. 26, 2021')

- Two officers from Uzbekistan completed the Customs Laboratory Professionals Program for 2 weeks -

As the RCL Korea contributes to the development of customs analysis technique and gains positive recognition internationally, the RCL Korea has run Customs Laboratory Professionals Programs to lay the foundation for further networks by cultivating professional analysts and building interpersonal networks with other WCO members.

In 2021, The RCL Korea ran a Customs Laboratory Professionals Program for two Uzbek officers from 15th to 26th of November. The program included:

- Introduction of WCO A/P RCL and the CCL Korea,
- Tobacco and manufactured tobacco substitutes analysis,
- DNA analysis on drugs of vegetable origin, drug analysis,
- Analysis of beverages containing alcohol,
- Plasticizer analysis,
- Analysis with X-Ray diffraction and X-Ray fluorescence.

Throughout the program, the RCL Korea not only established the groundwork for strengthening ties and exchanging information with its Uzbek counterpart, but also maintained its positive images as a technologically advanced member in customs analysis. Since we received requests on what should be added to the program, we will consider what is best for trainees in the next Customs Laboratory Professionals program and formulate action plans for the interaction between the CCLs of Korea and Uzbekistan to carry out.









3. 2021 LAC Online Workshop on Capacity Building for Digital Customs

('Dec. 7, 2021 - Dec. 10, 2021')

- Ninety middle managers from Colombia, Costa Rica, Ecuador, Peru, Jamaica, Suriname, Paraguay, Bolivia, and Panama attended –

The 2021 LAC Online Workshop on Capacity Building for Digital Customs was held from December 7th to 10th and The RCL Korea participated and delivered a presentation on analytic technology. Approximately ninety middle mangers from nine countries (Colombia, Costa Rica, Ecuador, Peru, Jamaica, Suriname, Paraguay, Bolivia, Panama) gathered in the online workshop in which IDB (Inter-American Development Bank) joined as a co-host.

The presentation started with introducing our laboratory tasks, facilities, laboratory operation, and analytical instruments. It also included the role of the RCL Korea in the A/P region and international activities, HS classification with analytical instruments such as SEM, XRD, XRF, and GC, and analysis cases.

The RCL Korea will continue to work on understanding demand for digital capacity of the countries through an in-depth analysis with the consulting results for later discussion.

4. The 1st meeting of the Heads of the WCO Asia/Pacific Regional Customs Laboratory

('May. 10, 2022')

- Five countries of WCO Asia/Pacific Regional Customs Laboratory participated

The Heads of the WCO Asia/Pacific Regional Customs Laboratory met online for the first time on May 10th, 2022. The purpose of the meeting was to strengthen mutual cooperation and explore ways of promoting information exchanges. It began with having the heads from the five countries introduce themselves and it was followed by exchanging and presenting information on activities of the WCO, ROCB A/P, RILO A/P and RCL.

The RCL Korea delivered a presentation after the other four regional customs laboratories in the A/P region and the presenter of The RCL Korea spoke about the structure of the organization that consists of one central customs laboratory and five local customs laboratories and the tasks that it performs by providing analysis & classification advice, research & technical guidance, and facilitating international cooperation. The presenter also emphasized the roles the RCL Korea plays in running capacity building programs such as training services and participating in international activities.

It was a great opportunity for the five countries in the A/P region that have their own RCLs to get to understand one another. Since they function as customs laboratories, there are common features such as carrying out analysis for HS classification or for narcotic drug identification. However, there are differences in terms of the ways that they operate their laboratories and scientific instruments in their possession.

Due to the pandemic, unfortunately, it took place online even though it was the first time the heads of the RCLs in the A/P region met. We believe it could have resulted in even better communications had it been a face-to-face meeting since we are certain that when it comes to exchanging views, sharing practical experience and expertise and even generating fresh ideas for the development of the RCL, there is no better way of facilitating improvements in customs analysis and seeking cooperation than offline meetings. We look forward to meeting with them in the near future head-to-head.

5. Participation in the Regional Seminar on Drugs and Drug Precursors held by RILO AP

('June. 16, 2022')

- Eighteen countries of WCO Asia/Pacific members, RILO AP, ROCB AP, UN ODC, and RCL Korea attended

On June 16th, 2022, RILO AP hosted the Regional Seminar via the online platform ZOOM. The RCL Korea attended this seminar as one of the presenters. There were five presenters whose presentations covered different topics on drugs within 30 minutes. The RCL Korea gave a presentation about illegal drug issues in the field of customs analysis. He introduced the identification methods of drugs such as methamphetamine, cannabis,

synthetic cannabinoids, LSD, ketamine and also provided examples of detected cases of these enumerated drugs.

6. Support and Management of Analysis Work in the WCO

1) The RCL Korea attended the 37th Session of the Scientific Sub-Committee of the WCO

The Scientific Sub-Committee (SSC) performs as an advisory body of the Council on questions involving chemical or other scientific matters. It also serves as a forum where the exchange of views with regard to customs-related scientific and engineering developments and best practices by the customs laboratory services of Council Members takes place. It plays a crucial role in assisting the HS Committee (HSC) and the Review Sub-Committee (RSC) by advising on classification questions involving scientific issues and providing scientific and engineering support and advice.

It normally holds at least one session a year. For the past two years, it had taken place online due to the pandemic caused by the spread of Covid-19 and The RCL Korea attended the 37th session that was held online from January 19th to 28th, 2022.

At the session, various topics, including HS classification of goods on the INN list, classification and analysis methods for specific goods or products that belong to Sections I to VII such as LPG, collagen sausage casing, and PCB, and capacity building activities with respect to customs laboratories were discussed.

The Delegate from Korea reported that, due to the pandemic, the year 2020 was unfortunate for Korea Central Customs Laboratory, not allowing them to run the Customs Laboratory Professionals Program, consisting of on-site training. In 2021, however, it successfully ran its Customs Laboratory Professionals Programs for two weeks by having invited and provided two staff analysts from Uzbekistan Central Customs Laboratory with learning opportunities through classification analysis, roles and responsibilities of RCL, and laboratory operation. He also added that Korea Central Customs Laboratory, as Regional Customs Laboratory, will continue to support capacity-building activities for WCO member countries. Finally, he informed that Korea Customs Service donates around 2.2 million Euros every year in supporting the WCO capacity building activities and stated that the RCL Korea will continue to make every effort to enhance the capacity of Customs

Laboratory areas and upgrade programs in close collaboration with Korea Customs headquarters and the WCO.

2) The RCL Korea attended the 68th and 69th Sessions of the Harmonized System Committee of the WCO

The Harmonized System Committee (HSC) acts under the overall direction of the WCO Council and Policy Commission with the purpose and scope of uniform interpretation and application, update, and promotion of classification of goods, and examination of general questions and policy matter regarding the HS.

The HS committee meets twice a year and each session lasts two weeks. It had been held online for the last two years due to the pandemic and The RCL Korea attended the 68th and 69th sessions that were conducted via an online platform respectively in September 2021 and March 2022.

At the 68th and 69th sessions, the RCL Korea presented opinions on HS classification of the agenda items such as rehydrated dried fish, rooibos tea, and presented an amendment to the Explanatory Notes clarifying the scope of heading 24.04. The participants shared views and exchanged opinions. Votes were taken on the discussed items of which HS classification was not decided during the meetings via the CLiKC! platform and the other ones that were not discussed due to lack of time or information were relegated to the next session.

As we prepared for the sessions, we fully appreciated every moment to discuss HS classification, which helped drive further studies into items at issue and exchange views. We hope to make more contributions to further progress in HS classification.

3) The RCL Korea attended the 59th and 60th Sessions of the Harmonized Review Sub-Committee of the WCO

The Harmonized Review Sub-Committee (RSC) is under the overall direction of the HS Committee. It pursues a review of the HS under the general guidance of the HSC by proposing amendments to the HS when it may be considered desirable according to the needs of users and to changes in technology or in patterns of international trade and preparing any consequential amendments to the Explanatory Notes and the Compendium of Classification Opinions for consideration.

It usually meets twice a year and each session lasts one to two weeks depending on the number of items on the agenda. It had been held online for the last two years due to the pandemic and The RCL Korea attended the 59th and 60th sessions that took place online respectively in November 2021 and May 2022.

WCO members were invited to review amendments of texts in HS Explanatory Notes and examine the addition of new headings and subheadings or alignment of meaning of texts in English and French versions of HS Explanatory Notes.

It was a great opportunity for us to consider what changes to be made in Explanatory Notes and Compendium of Classification Opinions as goods and products change how we trade when they are newly produced or no longer consumed by participating in this meeting. It also helped understand the way the WCO members view items at issue.

Introduction

Do you happen to know about the integrity efforts of the WCO? I would like to share one of the very interesting Programmes of the WCO, which is called the Anti-Corruption and Integrity Promotion (A-CIP) Programme. It aims to achieve a healthy Customs organization through improved integrity. Needless to say, this goal is the same as shared by members of the Asia Pacific region. If you are interested in the A-CIP, do not miss this opportunity.



Summary of A-CIP

Launched in January 2019, the A-CIP Programme responds to the recognized high costs of corruption in Customs. The Programme aims at improving the business and law enforcement environment for cross-border trade in selected WCO member countries by making changes to the operational and administrative context that restricts corrupt behavior and promotes good governance in Customs services. These changes are guided

by and in line with the ten key factors of the WCO Revised Arusha Declaration (https://rad.wcoomd.org/) Concerning Good Governance and Integrity in Customs with initial financing from the Norwegian Agency for Development Cooperation (Norad), and additional funding from Canada, the A-CIP Programme currently supports more than 20 beneficiary countries in their efforts to combat corruption and promote integrity. Activities and achievements

The bilateral component of the Programme involves delivery of WCO technical assistance and capacity building to help selected WCO member countries undertaking measures to implement priority areas of the Revised Arusha Declaration. For each administration, a multi-annual action plan is developed along with clear benchmarks and performance measurement criteria. The Programme also contains a multilateral component to create an enabling environment for WCO Members to implement A-CIP Programme measures by leveraging regional and international initiatives in parallel, and to build WCO instruments and tools.

As for the recent achievement, the WCO A-CIP Programme for Customs has developed a new Internal Affairs e-learning module. The course is now available in English on the WCO CLiKC! e-learning platform. This training aims at emphasizing the added value and impact of an Internal Affairs function in fighting corruption and promoting integrity through prevention and investigation activities. It will provide Customs officials with a better understanding of Internal Affairs-related processes, procedures, and activities that will positively impact their level of integrity and that of the overall administration.



Integrity in the Asia Pacific region

The region's Members have long been active in combatting corruption and we hope you will all be participating in the WCO's next Integrity Sub-Committee Meeting (link on wcoomd.org), to be held in hybrid form 27-28 February. In addition, we draw your attention to the WCO A-CIP Programme, which has been supporting select Members to implement integrity initiatives in line with the WCO Revised Arusha Declaration, as well as contributing to new tools and instruments to help all WCO Members. An opportunity may be on the horizon to expand this Programme's support to Members in the Asia-Pacific region. The First WCO BACUDA¹ (Data Analytics) Scholarship Programme²

I. Introduction

The use of data by Customs is not new. However, Big Data³ and algorithms⁴ are certainly providing new opportunities for Customs, while also raising new challenges in the implementation of Data Analytics. Such challenges require specific approaches to be considered, as well as specific policy attention to develop the appropriate organizational and technical capabilities needed to take advantage of the explosion in data, and to gain the insights that will help Customs make better informed decisions.

Over the past few years, the WCO Secretariat has made numerous efforts to raise awareness among WCO Members about the potential benefits of data analytics, and to support them in their journey towards a successful implementation of the analytics function⁵. Before reviewing the BACUDA (Data Analytics) Scholarship program, I would

like to present the WCO BACUDA project to easily understand the whole picture of program.

II. WCO BACUDA Project

The WCO BACUDA project was launched in September 2019 as a collaborative research platform focused on data analytics. The project aims to develop data analytics methodologies (algorithms) in open-source languages so that all the Members can employ them with their own data. It should be necessary to know programming language, such as Python⁶, R⁷ to understand the outcomes of the projects, because the algorithms are based on the languages.⁸

In this regard, it should be necessary to illustrate cross-institutional collaborative efforts to develop the analytical capabilities of the Members, the WCO will continue working on BACUDA project in collaborative research with Members and external experts⁹.

One of the popular algorithms developed by the WCO BACUDA Project team is "DATE¹⁰ model" as below. The DATE consists of three stages. The first stage pre-trains a tree-based classifier to generate cross features of each transaction. The second stage is a dual attentive mechanism that learns both the interactions among cross features and the interactions among importers, HS codes, and cross features. The third stage is the dual-task learning by jointly optimizing illicitness classification and revenue prediction.

Ecosystem based on trust, embrace a data Culture by bridging the human resource gaps and foster a collaborative culture among Customs administrations. Within this framework, the 1st WCO and SKKU Data Analytics Scholarship Programme had been launched in January 2022 in close collaboration betweenthe World Customs Organization (WCO) and Sungkyunkwan University (SKKU).


⁶ Python is an interpreted, high-level, general-purpose programming language. Created by Guido van Rossum and first released in 1991.

⁸ Due to my preparation of this paper, I studied basic tutorial courses on the python and R about 2 weeks to understand the project. It should be more than 2 months to master the language fully.

¹⁰ It is called a <u>Dual-Attentive-Tree-aware-Embedded (DATE)</u> neural network model to assist Customs administration to better detect transactions presenting risks of fraud by implementing a pilot test to verify its performance with real-time import data of two Nigerian ports in Tin Can (in Lagos) and Onne (in Port-Harcourt) since March 2020. III. FRAMEWORK OF THE PROGRAMME

This programme offers a 5-month, non-degree programme: one month online and four months face-to-face.¹¹ The aim of this programme aims at enhancing capacity-building of customs officials on data analysis. Data analysis is a tool by companies and governments in their businesses for years to drive priority-setting, decision-making, performance measurement, budget planning and forecasting, and operations.

Customs has a substantial amount of data at its disposal, beginning with data submitted for the Customs clearance process. Thanks to the development of digital technology, Customs can tap into data from other government agencies, commercially available databases, and open-source information platforms, such as digitized global public records and multilingual news sources.

Accordingly, the framework of the programme includes;

- Fundamentals of Big Data Analytics
- Machine Learning Fundamentals
- Python Programming

¹¹ The WCO and SKKU (Sungkyunkan University in Korea) launched the Data Analytics Scholarship Programme on Monday, 24th January 2022, with the financial support of CCF-Korea as part of the BACUDA project of the WCO Capacity Building Directorate. Due to the current COVID-19 regulations, the first component of the scholarship programme is being conducted through a web conference platform. One month of online classes preceded an offline curriculum at the SKKU in the second quarter of the year 2022.

- Applied Advanced Analytics
- Data Technology
- WCO BACUDA algorithm
- · Leadership and Management

IV. SELECTION OF PARTICIPANTS¹²

- The number of participants for the programme will be twelve. Given the goal of the programme, they should be management-level officials of Customs in developing countries.
- 2. The candidates should be in good health, preferably within the age range 45-25.
- 3. Officials who apply for the programme shall meet all the following requirements:
 - a. Certification of the completion of Data Analytics beginner course on the WCO
 CLiKC!
 - b. have at least two or more years of work experience in Customs Data Analytics
 - c. Proof of English proficiency (both speaking and listening)

V. FUNDING

The programme will be financed through CCF-Korea provided by the Korea Customs Service.

 For the face-to-face program, the Fund will cover travel costs, admission fees, tuition fees, institutional costs, accommodation costs and other approved incidental expenses to enable the participants to complete the programme.

¹² Twelve customs officials from the six WCO regions, carefully selected from over 60 applicants, are participating in the program of 2022. VI. PRGRAMME SCHEDULE AND DESCRIPTION

1. Course Description

The program consists of one month of online courses and four months of offline activities. The courses will be divided into the following nine modules.

- 1) Fundamentals of Big Data Analytics (Online)

19 - 22 December 2022, Bali, Indonesia



The WCO Regional Workshop on the Revised Kyoto Convention (the RKC) for Asia Pacific members was held in Bali Indonesia from 19-22 December 2022 sponsored by the Customs Cooperation Fund of China (CCF-China). From ROCB A/P, Ms. Zhengqing Ye, the Program Manager and Operation Manager of the CCF-China and Ms. Vareemon CHAIRUNGSRILER, the Program Coordinator supported in organizing this workshop.

Ms. Ye warmly welcomed the experts and participants to join the RKC regional workshop, and she emphasized the importance of RKC in the trade facilitation context in her opening remarks. During the workshop she introduced ROCB A/P's capacity building activities such as organizing workshops and publishing various materials for information sharing. She demonstrated a commitment to assisting AP Members in building their capacity by ROCB A/P. She also explained the Follow-up Actions Survey, which aims to

take a snapshot of the impact of WCO capacity building activities on AP Members' performance and encouraged the participants to take action to utilize lessons learnt from this workshop.

This event gathered a total of 27 Customs officials from the region attended the workshop in-person, and about 15 officials joined online from the General Administration of Customs of China (GACC) and the Korea Customs Service. Overall, 22 Contracting Parties and 2 Observers (Timor Leste and Brunei Darussalam) to the RKC participated in the workshop.

As we all know, the RKC presents a blueprint for modern and efficient Customs procedures in the 21st century to facilitate legitimate trade while not compromising the Customs control function. It provides a comprehensive and basic set of international Customs standards; it also serves as a basis for other Customs instruments and constitutes a benchmark for successful capacity building activities. In this regard, reviewing and understanding the RKC and ensuring proper implementation by customs administrations is of vital importance.

This regional workshop provided ample opportunity for our Members Administrations to better understand the implementation issues and challenges faced by the contracting parties. In addition, the workshop was briefly updated on the relationship between the RKC and the WTO Trade Facilitation Agreement and on the status of the ongoing comprehensive review of the RKC.
